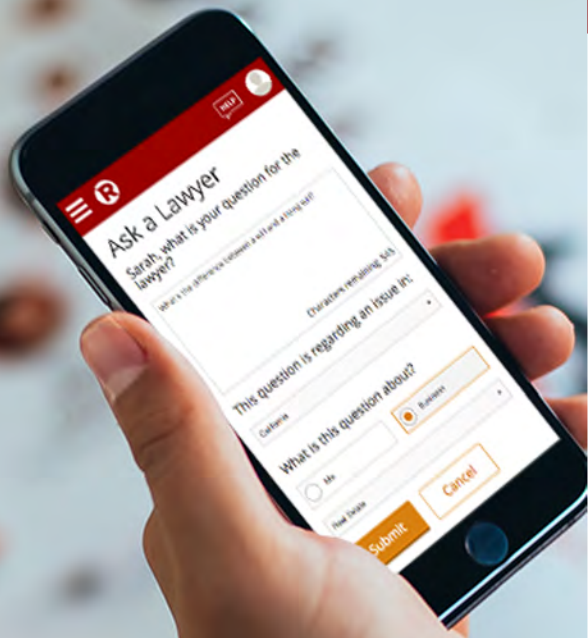

This document allows you to declare your wishes regarding the withholding or withdrawal of life-sustaining procedures and make health care decisions for you in the future.

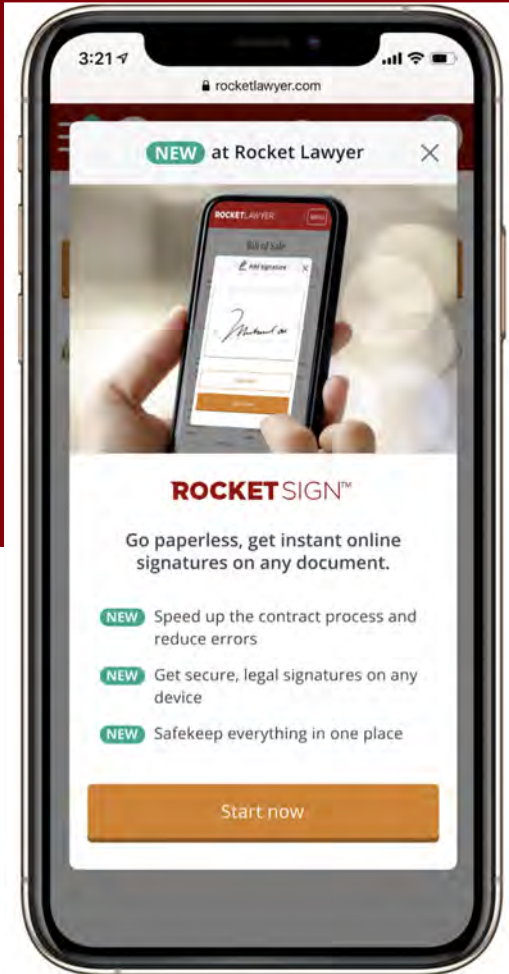



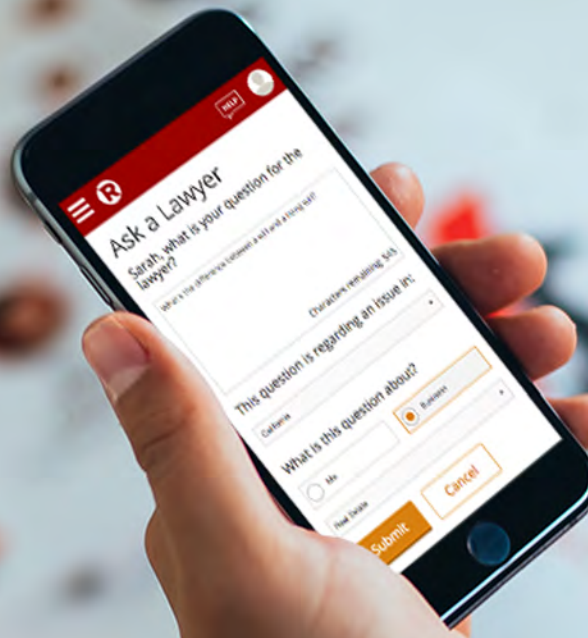
